## Terms and Conditions

1. Approximately 150 Nos. of Piglet is required at a ratio of 1 male per 4 female piglets and Pig-feed (Maize Crush: 60%, Rice/ Wheat bran: 10%, Oilseed cake: 20%, Fish meal: 8% and Mineral mixture (powder): 2%, which is to be supplied in five different TSP villages, which is situated within 8 (eight) K.M. from this office under Sidli-Chirang Development block of Chirang district. The age of the piglets should be more than 3 months.
2. The bidder shall quote the rate including all taxes and carrying charge of the piglets and pig feeds separately along with all relevant papers, failing which the bid may be treated as non-responsive. The quotation shall be sealed and superscripted at the top of the sealed cover "Quotation for supply of Piglet, KVK, Chirang, Kajalgaon – 783 385".
3. The bid submitted by the bidder shall remain valid for a period of minimum 90 (ninety) days. Bids not conforming to this provision will be treated as non-responsive and rejected.
4. Delivery of the piglets and pig feeds shall have to be completed strictly within 30 (thirty) days from the date of issuing supply order. Quotations not conforming to this provision may be rejected at the discretion of the purchaser.
5. To facilitate prompt evaluation, the bidder shall provide a Government Veterinary Doctor's certificate for fitness, age of the Piglets and breed of the Piglets, failing which the bid may be treated as non-responsive, at the discretion of the purchaser.
6. Rates should be quoted clearly both in words and figures separately for each item. There should not be any overwriting. Corrections, if any, should be made by crossing out, initiating, dating and re-writing.
7. The prices quoted shall be fixed and not subject to adjustment/variation during the performance of the contract.
8. Payment by A/C payee Cheque shall be made after receipt of the items in good condition. No advance payment will be made for the items.
9. Wherever the laws and regulations require deduction of taxes at the source of payment, the purchaser shall affect such deduction from the payment due to the supplier, the remittance of amounts so deducted and issuance certificate for such deductions shall be made by the purchaser as per the laws and regulation in force.
